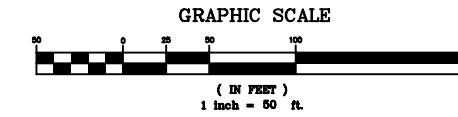


Map Showing A Specific Purpose Survey of
